Minutes Juggers Meeting on 09/23/2021

The monthly in person & Zoom Meeting of the Juggers was called to order by Vice President Steve O'Brien at 7:02 PM, from Round Table Pizza in San Mateo. A moment of silence was held to remember Juggers who have passed & those unable to attend.

Attendance: There were 25 attendees in person at the meeting and 5 via Zoom.

Secretary's Report: Minutes were accepted as published in the Newsletter.

Treasurer's Report: Sandy reported a Treasury Balance of \$5,934.51.

Safety Committee: JohnL reported that NHRA Rules were Amended August 5th and 16th. Only ones pertaining to classes we run is the permitting of new helmets rated FIA: 8860-2010, 8860-2015 or 8860-2018.

Web Site Committee: JohnL reported that the new site is up. Still need to put in pictures that more represent the categories such as High School Program, etc. Need to add the history section which is being totally redone. The History section is the most complicated and perhaps most important section. Sandy is working with the web site builder Nancy Clothier and is getting more materials from Kelly Hungerford. 
